

### **2026 Instructor Submission Guidelines**

The 37<sup>th</sup> Annual Continuing Challenge HazMat Emergency Response Workshop September 8 – 11, 2026, Sacramento, California

The Continuing Challenge Committee is seeking course proposals from instructors on new ideas and practical solutions to the toughest challenges facing today's HazMat response teams. This is an opportunity to present innovative solutions, experiences, and advancements in hazardous materials response to the emergency response community.

The following is a list of course content that is of particular interest to workshop students:

- Basic HazMat emergency response
- Advanced courses
- Industry specific such as chlorine, ammonia, propane
- Alternative fuels
- Radiological
- Monitoring/detecting/testing
- Responder health and safety
- Environmental and Community Impacts of HazMat Emergencies
- Professional skills in leadership and communication
- Weapons of Mass Destruction/ Explosives/Hazardous Devices
- Behavioral health awareness for all, PTSD
- Fentanyl and other Designer Drugs
- Lithium Batteries and their problems
- Emergency and Disaster Management
- Infectious Diseases and HazMat Response Community

Classes may be presented in lecture or panel discussion format and should include user-friendly and applicable tips and tricks that students can bring back to their respective organizations to implement. Students enjoy instruction that includes exercises, handson activities, and case studies.

**Submission deadline:** March 15, (Midnight, Pacific Standard Time).

Courses presented are 8, 4, or 2 hours long. **8-hour classes are held on Tuesday only.** 

Courses may include specific product and company information provided the presenter includes a demonstration of the product and the course includes the science, chemistry, etc. of the product.

- 2. Submission of a proposal does not guarantee participation in the Continuing Challenge HazMat Emergency Response Workshop.
- 3. Submitting a proposal constitutes consent from all presenters to be photographed by the Continuing Challenge during the Workshop and for the Continuing Challenge to use any such photographs for promotional, communication, and planning purposes.
- 4. Once a submission is selected, the Continuing Challenge reserves the right to revise program titles and edit the program summary.
- If the submission is selected, information regarding important deadlines and requirements will be provided and must be adhered to.

#### Submitting a course proposal is simple.

- 1. Go to <a href="www.hazmat.org">www.hazmat.org</a> and log in, or create a member profile and then log in.
- Hover over the Workshop tab and scroll down to Instructors, this will take you to the instructor registration page.
- 3. Complete all the steps in the application process and click submit.
- 4. Check your email. You should receive a confirmation email from <a href="mailto:info@hazmat.org">info@hazmat.org</a> within 30 minutes. If you do not receive an email, it is possible that your proposal was not successfully transmitted for review, or is in your spam folder. # Lead Instructor Responsibilities. If you log on and complete the Course Proposal, you will be listed as the "Lead Instructor", and this cannot be changed. Lead Instructors have the following responsibilities:

- Read the submission information and instructor guidelines. Share this information with all additional faculty.
- Distribute information regarding presentation to all faculty members (i.e. acceptance, rejection, scheduling).
- Ensure you obtain permission for use of any and all copyrighted materials.

## For 8-hour courses total faculty is limited to 4:

- Lead Instructor Maximum 1 per 8-hour course.
- Co-instructor Maximum 1 per 8-hour course.
- Adjunct Instructor Maximum 2 per 8-hour course.

## For 2- or 4-hour courses total faculty is limited to 3:

- Lead Instructor Maximum 1 per 2- or 4hour course.
- Adjunct Instructor Maximum 2 per 2- or 4-hour course.
- Note: There are no co-instructors for 2- or 4-hour classes.

It is the responsibility of the Lead Instructor to ensure that all individuals listed as faculty appear at the Workshop as stated in the application.

#### **Instructor Registration Fee Waiver Policy:**

Workshop registration fees are waived for <u>Lead</u> <u>and Co-instructors</u> only. Meals (Tuesday – Friday lunch, Wednesday evening dinner) are provided. Registration fees are non-transferable. No other expenses are covered.

 Adjunct instructors receive meals only on the day of instruction.
